Quality Control

1. Total quality control must be managed by the manufacturer of the hose, including weaving of the jackets, manufacture of the linings, physical and laboratory testing of all raw materials and finished products. A system of accurate documentation shall be maintained on hydrostatic tests, and test results shall be provided to the municipality upon request within five business days from the time a request is made. This documentation shall include the test date, inspector's name, and all test results.
2. The hose manufacturer shall have a quality control program in place that assures the fire hose is manufactured to the NFPA 1961 latest edition standard.
3. The manufacturer shall keep documentation of all design tests that show compliance with the requirements of the NFPA 1961 latest edition standard.
4. Complete production records of inspection and tests shall be available to the County.

Service Life

The fire hose furnished under the terms of this bid shall have a potential service life / warranty of not less than ten (10) years, aggressive municipal fire service. The fire hose shall be capable of withstanding normal actual duty for a period of not less than ten (10) years, without deterioration that would render the hose unfit for service, barring mistreatment or accidental damage. All other requirements shall conform to NFPA 1961 latest edition standards.

Aggressive Municipal Service

Aggressive municipal service, for this document, is construed to mean the use of fire hose for interior offensive structural fire attack for the purpose of fire extinguishment, during the incipient phase and open burning phase of fire progression. The hose will encounter environments coincidental with that purpose. This will include, but is not limited to; dragging the hose through a burned or partially burned structure, direct contact with flooring, furniture, normal building construction materials that are damaged or undamaged, broken glass, and partially extinguished smoldering material. Purposefully excluded are fully involved structural fires where direct flame contact with the hose is likely.

- Actual duty, for this document, is construed to mean the period during which the hose is in active service outside the storeroom.
- Hose markings shall be in accordance with NFPA standard 1961 latest edition, and shall specify the name of the manufacturer and the month and year of manufacture and the words "Attack Hose, Service Test To _x_x_ PSI" (the hose service pressure).
- Marking of the couplings shall be in accordance with NFPA standard 1961 and 1963 latest edition. Stamped (example): 1.5" NH, YFD, Sequential 01-11, 02-11

Hose Internal Diameter

Minimum diameter shall not be less than the hose trade size.

Fire Hose Specifications

 - a. Shall have standard NH / NST couplings, one male, one female; couplings shall be aluminum or better.

- b. Shall be polyester double jacket weave with rubber inner liner with rubber backing and have a Dura Cote- treatment or equal.

 - d. Shall be in 50 foot lengths.
 - e. Shall be stenciled, example: "Elmsford F.D." and "Live Oak" or "E.F.C."

- a. Shall have standard NH / NST couplings – one male and one female; couplings shall be aluminum or better.
 - b. Shall be polyester double jacket weave with rubber inner liner with rubber backing and have a Dura Cote- treatment or equal.
 - c. All sections of hose shall be in accordance with NFPA 1961 standard.
 - d. Shall be in 50 foot sections.
 - e. Shall be stenciled, example: "Elmsford F.D." and "Live Oak" or "E.F.C."

- a. Fittings will be (NYC) New York Corp is thread 3.00x8tpi. Aluminum Coupling.
 - b. Both male and female couplings to be stamped per dept. requests
