REDICARE REPRESENTATIVE WILL DETERMINE A VISIT SCHEDULE WITH EACH SITE AND RESTOCK AS NEEDED, TO MAINTAIN OSHA/ANSI REQUIREMENTS. Each service visit, the kit should be wiped with a disinfectant wipe per ANSI Z308.1-2021 requirements. Wall-mountable metal first aid cabinet with door pocket liner. Hinged door with two lockable metal snap closures on the opening side and carry handle on top. Cabinet has shelves and labeled pockets to hold all supplies in an orderly and neat manner so that items can be easily seen and accessed quickly when needed. Cabinet options should arrive stocked with prepackaged first aid items, which, in total, meet or exceed the following initial fill, based on the respective request.

It is noted that this fill meets and exceeds ANSI/ISEA Z308.1-2021 "Minimum Requirements for Workplace First Aid Kits & Supplies" Class B referred to by OSHA for most workplaces. If the ANSI/ISEA Z308.1 or OSHA requirement changes, the initial fill should be updated to meet or exceed the new requirement. Per ANSI Z308, first aid kits should be inspected at least once per month or following and incident when product is used. Following are the required contents of the kits – contents must meet or exceed the noted quantity of individual items at the time of installation. Note, there are separate contents listings for Class A kits and Class B kits depending on the needs of the facility. Kits installed within any food prep areas shall replace fabric bandages to detectible blue plastic bandages and include Medium and Large finger cots.
