THIS FILE PRICE IS AVAILABLE TO OTHER MUNICIPALITIES, VILLAGES AND POLITICAL SUBDIVISIONS. **ALL COSTS FOR DELIVERING PRODUCT WILL BE THE RESPONSIBILITY OF AWARDED VENDOR.** THE INITIAL AGREEMENT SHALL BE FOR A PERIOD OF **TWELVE (12) MONTHS** WITH AN OPTION TO EXTEND FOR FOUR (4) ADDITIONAL SIX (6) MONTH PERIODS.

PRICING STRUCTURE

ORDER QUANTITY WILL BE PER QUANTITY SCALE IN THIS BID. **THE MINIMUM ORDER QUANTITY FOR ANY ORDER SHALL BE 50 KITS PER SIZE.**

AFTER THE INITIAL 90 DAY PERIOD, PRICE INCREASES MAY BE CONSIDERED, IF NECESSARY, ON A MONTH-TO-MONTH BASIS. ANY REQUEST FOR A PRICE INCREASE MUST BE IN WRITING AND MUST BE BASED SOLELY UPON MARKET FLUCTUATIONS DUE UNFORSEEN CONDITIONS BEYOND THE VENDORS CONTROL. SUCH REQUEST MUST INCLUDE A PRICE QUOTE, AND ANY SUPPORTING MANUFACTURER DOCUMENTATION OR ANY DOCUMENTATION REQUESTED BY THE COUNTY. **SUPPORTING DOCUMENTATION MUST BE SUBMITTED WITH EACH PRICE ADJUSTMENT REQUEST.** ANY SUCH REQUEST IS SUBJECT TO THE APPROVAL OF THE WESTCHESTER COUNTY PURCHASING AGENT.

THE TERMS AND CONDITIONS OF EACH EXTENDED PERIOD SHALL BE THE SAME. THE OPTION TO EXTEND SHALL BE EXERCISED IN WRITING PRIOR TO THE EXPIRATION DATE.

PACKAGING REQUIREMENTS

*A KIT CONSISTS OF TWO SEPARATE POLY ZIPLOC BAGS, (ONE LARGE PPE KIT AND ONE SMALL PPE KIT, AS DEFINED HEREIN).

*EACH INDIVIDUAL BAG SHALL HAVE AN APPROXIMATE ¼" HANG HOLE PUNCHED INTO THE TOP ABOVE THE ZIPPER TRACK. EACH OF THE BAGS SHALL BE ATTACHED TO ONE ANOTHER. THE PUNCTURE MAY NOT BREACH THE STORAGE COMPARTMENT OF THE BAG TO LIMIT MOISTURE AND AIR CONTACT WITH ITEMS.

* BAGS SHALL BE ATTACHED BY THE HOLE WITH TWINE, METAL RING, ZIPTIE OR VENDORS PREFERRED METHOD. (NO STAPLES, CLIPS OR PENETRATIONS TO LIMIT MOISTURE AND AIR CONTACT WITH ITEMS).
