- A chair
- A working surface
- Nearby access to clean running water
- An electrical outlet
- · Close proximity to the employee's work area
- Full shielding from view
- Freedom from intrusion from other persons in the workplace or the public. Ideally, but not mandated, that would be a private room with a lockable door.
