Prices for servicing the various types and size fire extinguishers shall include all labor and materials (exclusive of parts) necessary to pick up, clean parts, charge with proper refill, test, seal, tag and return to proper locations within five (5) days from pick up. Part prices shall include installation.

If fire extinguishers are removed from any location for any reason, the vendor will be required to leave similar type and size loaner fire extinguisher at the location.

Vendor is required to leave a signed receipt with the County department any time a fire extinguisher is removed and submit signed work order with invoice. The receipt shall list the type, model and capacity of each fire extinguisher taken and the vendor will be responsible for any that are not returned.

All serviceable units or any unit that is taken out of service for non-compliance with regulations, are to be returned with the notation shown on a duplicate receipt (condemned cylinder form). The receipt must show the test date, the reason why the unit was taken out of service and the name of the person performing the test.

Routine maintenance and testing of all fire extinguishers shall be done in accordance with manufacturer's requirements as well as specified requirements with the most recent NFPA 10 edition. This service shall be made over the first twelve (12) months of this agreement (sooner if required) and each twelve (12) months thereafter, and shall cover weighing, testing, sealing, tagging and general cleaning in accordance with NFPA Standards. The vendor shall be required to develop a schedule for future visits from this period. The vendor shall issue this schedule to department representatives listing appropriate future visits. Hydrostatic testing of fire extinguishers shall be done when required in full accordance with DOT regulations, by a DOT certified agency, high pressure testing with current RIN #. When needed, yearly maintenance and tagging service shall include labeling of all applicable units with HMIS labels.

Six (6) year maintenance will be performed on fire extinguishers only when required.

Successful vendor will provide service during normal working hours (8:00 AM – 5:00 PM), Monday through Friday.

Employees of the successful bidder will present on request, company issued identification to insure entrance into all County facilities and certifications pertaining to portable fire extinguisher inspection and maintenance by third party or manufacturer of equipment.
