PRODUCT WEIGHT, BREADED WITH BLEACHED WHEAT FLOUR, ARTIFICIALLY-HYDROGENATED SOY BEAN OIL, SALT, NON-FAT DRY MILK SPICES, MSG, SODIUM BICARBONATE YEAST, DEXTROSE, LECITHIN, MALT SYRUP, NATURAL FLAVORING WITH MONO AND DI-GLYCERIDES. BATTERED WITH WATER, BLEACHED WHEAT FLOUR, SALT, SPICES, GARLIC POWDER, MSG AND NATURAL FLAVORING. BREADED SET IN VEGETABLE OIL. CHICKEN PATTIES AND CHICKEN PARTS ARE NOT ACCEPTABLE.

PACKING: PACKED 10 POUNDS PER BOX.

PRODUCT TO BE PRODUCED FROM FRESHLY SLAUGHTERED CHICKEN. NO FROZEN OR PREVIOUSLY FROZEN CHICKEN MAY BE USED. THE COOKED BREADED FILLET SHALL BE PRODUCED IN A MANNER THAT WILL RESULT IN A TENDER FINISHED PRODUCT. THE BREADING SHALL BE A COMMERCIALLY ACCEPTABLE PRODUCT THAT WILL PRODUCE THE DESIRED COLOR, TEXTURE, CRISPNESS, AND FLAVOR IN THE FINISHED PRODUCT. BREADING SHALL NOT EXCEED 20% OF THE WEIGHT OF THE BREADED FILLET. THE FINISHED COLOR OF THE BREADED FILLET MUST BE A GOLDEN COLOR.

THE COOKED, BREADED FILLET SHALL WEIGHT 4 OUNCES PLUS OR MINUS 10 PERCENT. FINISHED PRODUCT WILL BE SAMPLED AND TEST WEIGHED IN ACCORD WITH USDA, POULTRY DIVISION PROCEDURES AND INSTRUCTIONS.

THE INDIVIDUAL FILLETS SHALL NOT BE SOGGY, OILY, DRY, OR EXHIBIT OVER-COOKING, OR HAVE AREAS OF UNDUE FLAKING OR MISSING BREADING. THEY SHALL BE FREE OF RANCIDITY AND FROM METALLIC, OVER-COOKED, BURNT, SCORCHED, BITTER, AND OTHER TASTES OR ODORS FOREIGN TO PROPERLY PREPARED AND COOKED PRODUCT. TOLERANCE FOR BREADING DEFECTS (FOR EXAMPLE, EXCESS RIDGES, LUMPS, AND AREAS WITH MISSING BREADING) WILL BE ACCORDING TO POULTRY DIVISION ONLINE AQL PROCEDURES AND INSTRUCTIONS.

CHICKEN, IQF, ONLY QUARTERED, ½'s WITHOUT GIBLETS AND NECKS, PREPARTED FROM RTC WHOLE FRYERS, 2½ POUNDS EACH BEFORE QUARTERING, U.S. GRADE A QUARTERS, PORTIONS TO BE UNIFORM IN SIZE, 10 OZ. AVERAGE. PACKAGING AND PACKING: LAYER PACKED WITH CASES COMPLETELY LINED WITH A 2 MIL LOW DENSITY POLY BAG. BAGS SHALL BE SECURELY CLOSED BY SEALING OR TYING (WIRE AND PLASTIC TIES UNACCEPTABLE). 60 PIECES/CASE, PACKED 27 – 32 LB PER CASE.
