PLEASE QUOTE YOUR PRICES TO SUPPLY THE COUNTY OF WESTCHESTER WITH LUMBER AND ALLIED BUILDING MATERIAL AND SUPPLIES AS REQUIRED FOR THE PERIOD JUNE 1, 2017 THROUGH NOVEMBER 30, 2017, WITH AN OPTION TO EXTEND THE AGREEMENT FOR UP TO TWO ADDITIONAL PERIODS, EACH NOT TO EXCEED SIX (6) MONTHS, UPON MUTUAL WRITTEN CONSENT, AT THE SAME PRICES (OR LOWER), TERMS, CONDITIONS, AND SPECIFICATIONS, PRIOR TO THE EXPIRATION DATE OF THE AGREEMENT.

ALL DIMENSIONAL LUMBER SHALL BE GRADE STAMPED MATERIAL. ALL PRICES MUST BE QUOTED IN ACCORDANCE WITH THE UNITS SPECIFIED FOR ALL MATERIALS ON A DELIVERED BASIS TO ANY LOCATION IN WESTCHESTER COUNTY. ORDERS WILL BE IN SPECIFIC (AS OPPOSED TO RANDOM) LENGTHS. BIDDERS SHOULD ANTICIPATE THAT MANY ORDERS WILL BE FOR THE LONGEST LENGTHS SPECIFIED. PRICING QUOTED SHALL BE FIRM FOR THE ENTIRE CONTRACT PERIOD, AND AWARDS SHALL BE MADE ON THE BASIS OF LOW BID FOR EACH ITEM, GROUP, OR ENTIRE BID.

DELIVERY WILL NOT BE ACCEPTED AFTER 3:00 P.M. AT ANY DESTINATION. STANDARD LUMBER SHALL REQUIRE NO MORE THAN A FOUR (4) DAY DELIVERY AFTER RECEIPT OF ORDER OR AFTER TELEPHONE ORDER FROM THE BUREAU OF PURCHASE AND SUPPLIES.

QUANTITIES SHOWN ARE APPROXIMATES ONLY FOR THE BID AND FILE PRICE PERIOD AND THE VENDOR HEREBY WAIVES ANY CLAIM FOR DAMAGES BY REASON OF ANY CHANGE IN ESTIMATED QUANTITIES.

ANY EXCEPTIONS TO THIS BID SHALL BE CLEARLY NOTED AND FULLY EXPLAINED. PRICES, TERMS, AND CONDITIONS CONTAINED HEREIN MUST BE EXTENDED TO ANY POLITICAL SUBDIVISION OF WESTCHESTER COUNTY.

THE COUNTY OF WESTCHESTER REMITS VENDOR PAYMENTS VIA AN ELECTRONIC FUNDS TRANSFER (EFT) PROGRAM KNOWN AS VENDOR DIRECT. IN LIEU OF RECEIVING A CHECK FROM THE COUNTY, PAYMENTS ARE REMITTED BY EFT AND AUTOMATICALLY CREDITED TO THE VENDOR'S DESIGNATED BANK ACCOUNT AT THE VENDOR'S FINANCIAL INSTITUTION. VENDORS DOING BUSINESS WITH WESTCHESTER COUNTY, WHO ARE NOT ALREADY ENROLLED IN THE VENDOR DIRECT PROGRAM, WILL BE REQUIRED TO PROMPTLY COMPLETE AND SUBMIT AN EFT AUTHORIZATION FORM SUPPLIED BY THE COUNTY IN ORDER TO BE PAID.
