IF FIRE EXTINGUISHERS MUST BE REMOVED FROM ANY LOCATION FOR ANY REASON, THE VENDOR WILL BE REQUIRED TO LEAVE SIMILAR TYPE AND SIZE LOANER FIRE EXTINGUISHERS AT THE LOCATION.

ROUTINE MAINTENANCE AND TESTING OF ALL FIRE EXTINGUISHERS SHALL BE DONE IN ACCORDANCE WITH MANUFACTURER'S REQUIREMENTS, AS WELL AS SPECIFIED REQUIREMENTS WITH THE NFPA 10-1998. THIS SERVICE SHALL BE MADE OVER THE FIRST SIX (6) MONTHS OF THIS AGREEMENT (SOONER IF REQUESTED), AND EACH TWELVE (12) MONTHS THEREAFTER, AND SHALL COVER WEIGHING, TESTING, SEALING, TAGGING, AND GENERAL CLEANING IN ACCORDANCE WITH DOT REGULATIONS. THE VENDOR SHALL BE REQUIRED TO DEVELOP A SCHEDULE FOR FUTURE VISITS FROM THIS PERIOD. THE VENDOR SHALL ISSUE THIS SCHEDULE TO DEPARTMENT REPRESENTATIVES LISTING APPROPRIATE FUTURE VISITS.
