SCOPE

Westchester County is soliciting bids for fire hose to supply political subdivisions (cities, towns, villages, school districts and fire districts) within the County of Westchester with a means of purchasing fire hose.

1. This is a cooperative effort among municipalities in Westchester County to:
 - a. Establish a contract as contractor's primary offering to municipalities in Westchester County.
 - b. Achieve cost savings for vendors and government agencies through a single bid process that eliminates the need for multiple government bids and multiple responses by vendors.
 - c. Combine the requirements of government agencies regionally to achieve cost effective pricing.

PAYMENT

All purchase and payment transactions shall be made directly between the Contractor and the municipality.

DELIVERY POINT

Delivery point shall be designated by the municipality. Each municipality will be responsible for its own delivery points, orders and invoices. Contractor is instructed to deal individually with the municipality on these matters.

TERM OF CONTRACT AND RENEWAL

The initial term of Contract shall be one year and commence upon notice from Westchester County to Contractor.

County shall have the right in its best interest to renew Contract for up to three (3) additional one (1) year periods. If County elects to renew Contract, County will provide notice to Contractor ninety (90) days prior to the expiration date of Contract. Failure to notify Contractor within this time period shall not operate as a waiver of County's right to renew Contract. Within ten (10) Business Days of receiving such notice, Contractor shall submit a signed renewal to County. Each renewal shall be on the same terms and conditions as the prior term.

NOTE TO CONTRACTOR

Contract Award Notification is not an order. Do not take any action under this contract except on the basis of purchase order(s) from the political subdivision.

CONTRACT QUANTITIES

Unless otherwise stated in the Specifications, unit prices shall not vary, notwithstanding any increase or reduction in the quantities of Goods or Services requested by the municipality, and no claim for damages shall be made by or allowed to Contractor by reason of such increase or reduction.

1. This is a Requirements Contract unless specifically stated otherwise, and the estimate of quantities of the Goods or Services required is approximate and shall in no respect be deemed a guarantee.
 - a. The quantities actually required to complete the Contract may be less or more than estimated, and, if less, then no action for damages or lost profits shall accrue to Contractor.
 - b. If the quantity(ies) varies from original estimated number or amount, then the Contract Price shall be adjusted accordingly.

Even if this is not a Requirements Contract, the County shall have the right to increase or reduce the quantity of Goods or Services by up to ten percent (10%) thereof.

REJECTION OF BID SUBMISSIONS

1. The County may reject a Bid Submission if:
 - a. the bidder does not provide any of the information or documents required;
 - b. the bidder misstates, misleads, or conceals any material fact in its Bid Submission or at any time in connection with this RFB;
 - c. the Bid Submission is not in compliance with law;
 - d. the Bid Submission is not responsive to the requirements of this RFB or the requirements of the Contract terms and conditions;
 - e. any part of the Bid Submission, such as the Bid Price, is conditional;
 - f. the Bid Submission, in the opinion of the County, contains unbalanced bid prices;
or
 - g. a determination that the bidder is not "responsible" (as defined by law) is made in accordance with law or County regulations.
2. The County reserves the right to reject all Bid Submissions whenever it deems it in the best interest of the County to do so. The County also reserves the right to re-issue the solicitation.

QUALITY CONTROL

1. Total quality control must be managed by the manufacturer of the hose, including weaving of the jackets, manufacture of the linings, physical and laboratory testing of all raw materials and finished products. A system of accurate documentation shall be maintained on hydrostatic tests, test results shall be provided to the municipality upon request within five business days from the time a request is made. This documentation shall include the test date, inspector's name, and all test results.
2. The hose manufacturer shall have a quality control program in place that assures the fire hose is manufactured to the NFPA 1961 latest edition standard.
3. The manufacturer shall keep documentation of all design tests that show compliance with the requirements of the NFPA 1961 latest edition standard.
4. Production records of inspection and tests shall be kept complete and available to the County and political subdivisions.

SERVICE LIFE

FIRE HOSE

The fire hose furnished under the terms of this bid shall have a potential service life of not less than ten (10) years, aggressive municipal fire service. The fire hose shall be capable of withstanding normal actual duty for a period of not less than ten (10) years, without deterioration that would render the hose unfit for service, barring mistreatment or accidental damage. All other requirements shall conform to NFPA 1961 latest edition standards. **A sample warranty shall be submitted with the proposed bid.**

AGGRESSIVE MUNICIPAL SERVICE

Aggressive municipal service, for this document, is construed to mean the use of fire hose for interior offensive structural fire attack for the purpose of fire extinguishment, during the incipient phase and open burning phase of fire progression. The hose will encounter environments coincidental with that purpose. This will include, but is not limited to; dragging the hose through a burned or partially burned structure, direct contact with flooring, furniture, normal building construction materials that are damaged or undamaged, broken glass, and partially extinguished smoldering material. Purposefully excluded are fully involved structural fires where direct flame contact with the hose is likely.

ACTUAL DUTY

Actual duty, for this document, is construed to mean the period during which the hose is in active service outside the storeroom.

HOSE MARKING

Hose markings shall be in accordance with NFPA standard 1961 latest edition, and shall specify the name of the manufacturer and the month and year of manufacture and the words "Attack Hose, Service Test To _x_x_PSI" (the hose service pressure).

COUPLING MARKING

Marking of the couplings shall be in accordance with NFPA standard 1961 and 1963 latest edition. Stamped (example): 1.5" NH, YFD, Sequential 01-11, 02-11

HOSE INTERNAL DIAMETER

Minimum diameter shall not be less than the hose trade size.

FIRE HOSE SPECIFICATIONS

- (1) **1 ½ Inch Attack Hose**
 - a. Shall have standard 1 ½" NH / NST couplings, one male, one female; couplings shall be aluminum or better.
 - b. All sections of fire hose shall be white with a solid red and blue line the entire length.
 - c. All sections of fire hose shall be red in color with a solid white stripe the entire length
 - d. Shall be polyester double jacket weave with rubber inner liner with rubber backing and have a Dura Cote- treatment or equal.
 - e. All sections of hose shall be in accordance with NFPA 1961 standard.
 - f. Shall be in 50 foot lengths.
 - g. Shall be stenciled, example: "Elmsford F.D." and "Live Oak" or "E.F.C."
- (2) **1 ¾ Inch Attack Hose**
 - a. Shall have standard 1 ½" NH / NST couplings, one male, one female; couplings shall be aluminum or better.

- b. All sections of fire hose shall be white in color with a solid red and blue line the entire length.
 - c. All sections of fire hose shall be red in color with a solid white stripe the entire length
 - d. Shall be polyester double jacket weave with rubber inner liner with rubber backing and have a Dura Cote- treatment or equal.
 - e. All sections of hose shall be in accordance with NFPA 1961 standard.
 - f. Shall be in 50 foot lengths.
 - g. Shall be stenciled, example: “Elmsford F.D.” and “Live Oak” or “E.F.C.”
- (3) **2 Inch Attack Hose**
- a. Shall have standard 1 ½” NH / NST couplings, one male and one female; couplings shall be aluminum or better.
 - b. All sections of fire hose shall be blue in color.
 - c. All sections of fire hose shall be orange in color.
 - d. Shall be polyester double jacket weave with rubber inner liner with rubber backing and have a Dura Cote- treatment or equal.
 - e. All sections of hose shall be in accordance with NFPA 1961 standard.
 - f. Shall be in 50 foot lengths.
 - g. Shall be stenciled, example: “Elmsford F.D.” and “Live Oak” or “E.F.C.”
- (4) **2 ½ Inch Attack Hose**
- a. Shall have standard 2 ½” NH / NST couplings – one male and one female; couplings shall be aluminum or better.
 - b. All sections of fire hose shall be tan in color,
 - d. Shall be polyester double jacket weave with rubber inner liner with rubber backing and have a Dura Cote- treatment or equal.
 - e. All sections of hose shall be in accordance with NFPA 1961 standard.
 - f. Shall be in 50 foot sections.
 - g. Shall be stenciled, example: “Elmsford F.D.” and “Live Oak” or “E.F.C.”
- (5) **3 Inch Supply Hose**
- a. Shall have standard 2 ½” NH / NST couplings – one male and one female; couplings shall be aluminum or better.
 - b. All sections of fire hose shall be Yellow in color,
 - d. Shall be polyester double jacket weave with rubber inner liner with rubber backing and have a Dura Cote- treatment or equal.
 - e. All sections of hose shall be in accordance with NFPA 1961 standard.
 - f. Shall be in 50 foot sections.
 - g. Shall be stenciled, example: “Elmsford F.D.” and “Live Oak” or “E.F.C.”
- (6) **4 Inch Supply Hose**
- a. Shall have locking Storz couplings on both ends in aluminum or better.
 - b. All sections of hose shall be yellow in color
