RESUSCITATOR, INHALATORS AND AIR PACK SERVICE

SCOPE OF WORK

Contractor shall provide the County of Westchester with resuscitator, inhalator, & air pack refill, service, and repair, as required.

Prices for servicing the various types and size resuscitators, inhalators, and air packs listed on the following pages shall include all labor and material (exclusive of parts) necessary to pick up, clean parts, properly refill, and return to proper locations within 48 hours from pickup.

The County of Westchester owns approximately 270 resuscitators, inhalators, and air packs throughout the county. This bid will be awarded on a low gross basis, using the approximate number of resuscitators, inoculators, air packs, & tanks, and the approximate number of parts and hydrotests expected as the basis for the award.

The successful bidder will be required to leave a signed receipt with county department any time he removes a resuscitator, inhalator, air pack, or tank, and to retrieve his receipt upon redelivery. The receipt shall list the type, model, and capacity of each unit, and the vendor will be responsible for any units that are not returned. Unserviceable units are to be returned with the notation shown on a duplicate receipt.

Note: it is estimated that for every \$1,450.00 in list value of parts purchased, there will be a labor requirement of one (1) hour, and the Award will be made using these figures.

Hydrostatic testing shall be done, in accordance with D.O.T. regulations, when required, by a D.O.T. certified agency. A certificate of hydrostatic testing is required.

Quantities shown are approximates only, for the bid and file price period, and vendor waives any claim for damages by reason of any change in estimated quantities.

TERM OF CONTRACT AND RENEWAL

The initial term of Contract shall be one year and commence on December 1, 2010 or upon notice from Westchester County to Contractor.

Westchester County shall have the right in its best interest to renew Contract for up to three (3) additional one (1) year periods. If the County elects to renew Contract, the County will provide notice to Contractor ninety (90) days prior to the expiration date of Contract. Failure to notify Contractor within this time period shall not operate as a waiver of County's right to renew Contract. Within ten (10) Business Days of receiving such notice, Contractor shall submit a signed renewal to County. Each renewal shall be on the same terms and conditions as the prior term.

At the end of the initial term or any renewal Contractor shall, at the County's written request for an additional partial term, provide services as specified in Contract for a period not to exceed six (6) months under the same terms and conditions as the prior term.
