EMPLOYEE AND DEPARTMENT RESPONSIBILITIES

EMPLOYEE RESPONSIBILITIES:

Employees may not cut or alter uniforms in any way.

Employees may not deviate from the programs that were designated for them.

Employees are strongly encouraged to utilize the laundering service. Any employee who chooses to wash at home will be responsible for any damages to garment(s).

Employees must realize that there are only 11 shirts (long and short sleeve combined) total so they must choose carefully what they want laundered. If they give ALL of their short sleeve shirts to be laundered, they will be left with only long sleeve shirts for the entire week and can roll up the sleeves.

DEPARTMENT RESPONSIBILITIES:

Departments may choose the color of shirts and pants for their respective divisions and job titles.

Departments are responsible for providing the vendor with specific examples, specifications, and design of departmental logos that they require on the uniform.

Advise vendor of the exact location at each site where garments are to be picked up and returned and remind contractor of hours of operation.

Departments must develop their own policy regarding uniforms and employees must adhere to it. At a minimum it must address the following:

- 1} When an employee must be in uniform.
- 2} When and if an employee may wear a department issued t-shirt in lieu of uniform shirt.



3} What program each employee is on

Maintain records of contract usage on a per man basis.

Responsible to advise the vendor of changes in service, i.e. clothing changes, location changes, and retirements, etc. in writing.

Each county department or using location will contact vendor directly with requirements, additions, replacements, and complaints in writing.

Each department or using location is to provide vendor with a roster of employees and their locations.

Each department or using location is responsible for making arrangements for measuring at a designated time and place and are to be scheduled at the employees work location during normal working hours
